Project Overview: Goals

Goals: assess the capacity of the Mexican and Central American governments to implement current migration partnership agreements and to manage migration flows, provide asylum, and reintegrate repatriated migrants; and identify other regional approaches to managing migration effectively



Project Overview: Objectives

Objectives:

- 1. Assess Mexico's capacity to manage migration flows, cooperate with the United States in combatting smuggling, provide protection for migrants where warranted, settle and integrate some migrants, and continue removing migrants to their countries of origin
- 2. Assess the capacity of the Salvadoran, Guatemalan, and Honduran governments to manage migration flows, address root migration causes, accommodate repatriated nationals, and enhance their asylum systems
- 3. Understand how Costa Rica and Panama can enhance roles in regional migration management
- 4. More fully understand factors driving current migration flows to better predict their intensity and impact on capacity of the Mexican and Central American governments to implement cooperative migration control strategies.
- 5. Recommend policy options to manage flows from El Salvador, Guatemala, and Honduras through Mexico to the United States, as well as other flows through Central America.



Data

- Use publicly available data on migration flows to the United States and Mexico from
 - DHS
 - Mexico's National Immigration Institute (INM)
 - International Organization for Migration (IOM)
- Conduct follow-up with government officials and service providers to obtain non-public data and verify public data
- Cross-check data through interviews with other government officials and international organizations



Field Work

- At least one researcher or consultant will carry out field work in Mexico, El Salvador, Guatemala, Honduras, Costa Rica, and Panama
- While there, researchers will conduct interviews with key informants in government (local and national), non-governmental organizations (civil society, service providers, academic), and international organizations
- Interview topics to include
 - National migration policies and politics
 - Institutional structures of government agencies
 - Capacities to follow through on existing efforts and agreements
 - Efforts to address root migration causes
 - Potential avenues for further cooperation on migration with the United States



Tasks

T.1	Task title: Meeting with the project champion (every 2-3 months) Task description: Set objectives in first call; evaluate progress and brief champion in subsequent calls.
Т.2	Task title: Quantitative research on migration flows from source countries (including outside the Western Hemisphere) and sub-regional/sub-national areas of origin within Central America and Mexico. Task Description: Quantitative analysis of publicly available data sets.
Т.3	Task title: Field research in Mexico, El Salvador, Guatemala, Honduras, Costa Rica, and Panama Task description: Research travel and interviews of government, non-governmental, and international organization informants in the countries relevant to the study. One research trip to each country.
T.4	Task title: Draft report for roundtable discussion Task description: Analyze findings from tasks 2 and 3 in a report to be discussed at the roundtable.
T.5	Task title: Roundtable to review study findings and develop policy options Task description: Develop agenda, plan roundtable, invite attendees, send draft report to attendees, and hold roundtable discussion at MPI in Washington, D.C. (Roundtable in month 11 but with planning over a 2-3 month period.)
Т.6	Task title: Publication of final report Task description: Revise draft report and incorporate comments and recommendations from roundtable; conduct internal review, editing, layout, and publication of report.
Т.7	Task title: Launch of final report (2 months) Task description: Release event at MPI and dissemination through media, social media, and web, with additional briefings for U.S, and other regional stakeholders as needed (funded outside the project).
